All others terms and conditions of the approval letter under reference will remain unchanged.

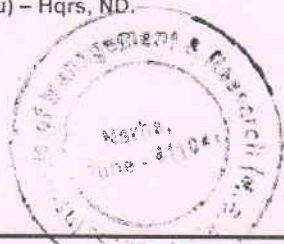
