

# Group stages protests in Mumbai, Solapur, Nagpur; demands quota cap at 50%

MUMBAI, AUGUST 25

WORRYING THAT excessive reservation in education has affected various communities deprived meritorious students of seats, members of 'Merit Save Nation' staged protests on Sunday in Mumbai, Solapur and Nagpur. In Maharashtra, reservation is 27 per cent till 2018-19. It included Constitutional reservations for SCs and STs, 10 per cent as well as 2 per cent given to women in Maharashtra. In 2019-20, reservation has gone up to 30 per cent. This... created a disturbance in the admission process of various professional courses. It led to mobilisation by unreserved and reserved category students...." The group said in a statement. According to the group, reservation policy should be based only on economic criteria and not on socially and economically backward classes irrespective of caste or religion. It called for an overhaul of

caste-based reservation policy by setting up a neutral panel to review it on a timely basis.

"Equal opportunities in education and employment should be available to everyone. Hence, reservation should not exceed 50 per cent and timelines should be defined to periodically review and reduce it gradually to zero once the goal of upliftment is achieved. A review committee should be in place to penalise fraudsters who avail of reservation benefits by obtaining certificates through fake documents. The reservation policy should be reviewed every five years to ensure its benefits reach the poor and needy," said Sudha Shenoy, one of the convenors of the protest in Mumbai's Azad Maidan.

A meeting was held on July 14 between Chief Minister Devendra Fadnis and members of the group to discuss the demands. "During our meeting the CM agreed on a few action points but government resolutions are awaited. Till then, our protest will continue," said Shenoy.

non-availability of protective kits, Gulhane said. "Shops selling farm inputs were directed to keep the kits ready for every customer. The agriculture department distributed 1,225 kits. Farm owners were given around 3,200 kits at 90 per cent subsidy through the zilla parishad. About 5,000 kits were made available through corporate social responsibility funds provided by Syngenta India Limited. Other farm input manufacturing companies have distributed 1,000 additional kits. The agriculture department has distributed

Joint Director (Agriculture), Amravati division, Subhash Nagare said, "Last year too, there were 200 admissions, down from about 900 in 2017. So, 17 admissions this year shouldn't be seen as a big number. In fact, this year, pest infestation is less than what it has been in the previous two years. Some farmers, however, still don't follow the instructions to not use a cocktail of insecticides."

Nagare said that the government hasn't banned three pesticides yet, including the largely used monocrotophos, as sought by the department.
