

- b. Your gross emoluments per month will be Rs. 25,000/- (Rs. Twenty Five Thousand Only per month all inclusive) this is the total cost to company (CTC) i.e. all deductions and contributions would be made from the above e.g. TDS, PF, PT, ESIC.
- c. Salary (point 'a' above) would mean all emoluments including all allowances payable. The Basic+DA for all future calculation for statutory and income tax purposes would be considered as 50% of this amount i. e. Rs.12,500/- per month.
